Item 4. Ownership.

The Fund directly holds (i) 1,400,001 shares of Common Stock, (ii) 1,286,960 warrants (“Warrants”) through which it has the right to acquire 128,696 shares of the Issuer’s Series A Preferred Stock (“Series A Shares”), which in turn are convertible into an aggregate of 1,286,960 shares of Common Stock, and (iii) 181,739 Series A Shares, which are convertible into an aggregate of 1,817,390 shares of the Issuer’s Common Stock.

The shares reported herein for the Reporting Persons represent (i) 1,400,001 shares of Common Stock held directly, and (ii) 849,420 shares of Common Stock that the Reporting Persons beneficially own based on the right to acquire, upon the exercise of the Warrants or conversion of the Series A Shares. The Warrants may not be exercised, and Series A Shares may not be converted if, after such exercise or conversion, the Reporting Persons would beneficially own, as determined in accordance with Section 13(d) of the Securities Exchange Act of 1934, as amended (the "Act"), more than 9.9% of the number of Shares then issued and outstanding (the "Ownership Blocker Limitation"). As a result, the Reporting Persons are currently prohibited from exercising the Warrants or converting the Series A Shares to the extent that such exercise or conversion would result in beneficial ownership of more than 2,249,421 shares of Common Stock.

The information required by this item with respect to each Reporting Person is set forth in Rows 5 through 9 and 11 of the cover page to this Schedule 13G/A. The beneficial ownership information reported is based on (i) 21,667,250 outstanding shares of Common Stock, as reported in the Issuer's Form S-3 filed with the Securities and Exchange Commission on December 30, 2022, plus (ii) 849,420 shares of Common Stock of which the Reporting Persons may acquire beneficial ownership upon the exercise of the Warrants or conversion of the Series A Shares, as limited by the Ownership Blocker Limitation.

RA Capital Healthcare Fund GP, LLC is the general partner of the Fund. The general partner of RA Capital is RA Capital Management GP, LLC, of which Dr. Kolchinsky and Mr. Shah are the controlling persons. RA Capital serves as investment adviser for the Fund and may be deemed a beneficial owner, for purposes of Section 13(d) of the Act, of any securities of the Issuer held by the Fund. The Fund has delegated to RA Capital the sole power to vote and the sole power to dispose of all securities held in the Fund's portfolio, including the shares of the Issuer's Common Stock reported herein. Because the Fund has divested voting and investment power over the reported securities it holds and may not revoke that delegation on less than 61 days' notice, the Fund disclaims beneficial ownership of the securities it holds for purposes of Section 13(d) of the Act. As managers of RA Capital, Dr. Kolchinsky and Mr. Shah may be deemed beneficial owners, for purposes of Section 13(d) of the Act, of any securities of the Issuer beneficially owned by RA Capital. RA Capital, Dr. Kolchinsky, and Mr. Shah disclaim beneficial ownership of the securities reported in this Schedule 13G/A other than for the purpose of determining their obligations under Section 13(d) of the Act, and the filing of this Schedule 13G/A shall not be deemed an admission that either RA Capital, Dr. Kolchinsky, or Mr. Shah is the beneficial owner of such securities for any other purpose.
